**TOWNSHIP OF RICHLAND
ORDINANCE NO. 504**

AN ORDINANCE OF THE TOWNSHIP OF RICHLAND, ALLEGHENY COUNTY, PENNSYLVANIA FOR THE PURPOSE OF AMENDING CHAPTER 15 (“MOTOR VEHICLES”) PART 3 (“RESTRICTIONS ON SIZE, WEIGHT, TYPE OF VEHICLE AND LOAD”) OF THE TOWNSHIP CODE OF ORDINANCES.

Section 1. Chapter 15, Part 301. Pertaining to the Establishment of Vehicle Weight Limits on Certain Streets and Bridges is hereby amended to add the following vehicle weight limit to the following street.

1. On the following bridges and streets or parts of streets, by authority granted by §4902(a), 6109(a)(7) and 6109(e) of the Vehicle Code, it shall be unlawful for any person or persons to drive any vehicle or combination having a registered gross weight in excess of the maximum prescribed below for that bridge or street or part of street, as the case may be:

<u>Street or Bridges</u>	<u>Portion</u>	<u>Registered Maximum Gross Weight</u>
Ben Miller Road	Entire Length	10 tons

2. Any person who violates any provision of this §15-301 shall be prosecuted under §4902 (a) and 4902(g-1) of the Vehicle Code, and upon conviction, shall be sentenced to pay a fine of \$150 plus \$150 for each 500 pounds, or part thereof, in excess of 3,000 pounds over the maximum allowable weight, and costs.

Section 2. Severability

If any chapter, section, subsection, paragraph, sentence or phrase of this ordinance is for any reason declared invalid by a court of competent jurisdiction, such decision shall not effect the validity of the ordinance as a whole or any section or part thereof other than the section or part thereof so declared to be invalid.

Section 3. Repealer

Any ordinance, chapter, section, subsection, paragraph, sentence or phrase of any ordinance conflicting with the provision of this ordinance shall and the same is hereby repealed to the extent of such conflict.

Section 4. Effective Date

This ordinance shall be effective immediately as a pending ordinance at the earliest time permitted by law.
