**A RESOLUTION OF THE TOWNSHIP OF RICHLAND APPROVING A REOPENING
PLAN FOR THE TOWNSHIP IN CONJUNCTION WITH THE CORONAVIRUS
(COVID-19).**

WHEREAS, the Township of Richland has followed orders and guidance provided by Federal, State and County governments to protect the health and welfare of the Township during the Declaration of Disaster Emergency, and

WHEREAS, as part of this Declaration of Disaster Emergency the Township closed facilities and altered various Township operations.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the Township of Richland hereby adopts the attached Richland Township Reopening Plan. The Plan will serve as a guide for the reopening of Township facilities and the resumption of operations with a focus on user and employee safety. The procedures will be updated by the Township Manager as situations and guidance from Government agencies changes.
